Elections of the new board (2018-2022)

As stipulated by the ISA47 statutes, we will designate a new president, a new vice-president, a treasurer/secretary and up to 8 board members. The new board will then have the opportunity to choose a newsletter editor.

The only requirement to be a candidate is to be an active member of the RC47 in due standing and to inform the current president of the candidacy 24 hours in advance. Candidate to the presidency, the vice-presidency and as treasurer/secretary may also send me a brief statement (1 to 2 pages) with a short bio and their perspective and project for our RC. These documents will be sent to all the RC47 members on July the 14th. These documents are by no way compulsory. It is just a way to get to know the candidates and their projects, as we will have limited time to present them during the short business meeting. Candidates who are members of the current board and wish to renew their position will be invited to present the balance of their activities for RC47 in recent years in a short statement (3 minutes) during the business meeting.

As our aim is to foster a more global sociology of social movements, it is particularly important to ensure some geographical balance among the board.

Three separate ballots will be organized to elect the president, vice and treasurer. The fourth vote will designate the eight board members. All the participants will be invited to select eight names among the candidates, taking into account their project and competencies as well as geographical balance of the future board.

How to present a paper at the congress? Brief guidelines

The usual length of a paper presentation at the ISA conference is 15 minutes, except if your panel chair or organizer send you different request. If there are 4 speakers or less in your session you should expect to get 18-20 minutes

- → Please keep your time. It will allow all the speakers to present their research in good conditions and to have a brief discussion after on the presented papers at the end of the session.
- → 15 minutes is a short period of time! It is important to go as straightforward as possible to the main argument of your article. What is the idea you really want to share with the audience?
- → It is often frustrating to present an in-depth research in just 15 minutes. The oral presentation is however only one of the ways you will present and discuss your research at the ISA congress. You should send your papers to the fellow panellists and to the audience. Informal exchanges that will happen throughout the week will provide other opportunities to carry on the conversations that started at the panel and to present your research to other colleagues.

If you plan to use a power point presentation, please send it to the panel chair and make sure you arrive 10 minutes at the session venue 10 minutes before its starts.

There are four different settings for the ISA47 panels.

- → Regular panel: A classic conference setting, with 4-6 panellists "on the stage" and a great audience. You may use a power point presentation, but it is by no means compulsory.
- → Roundtable sessions: Four to five round tables will be set in a room, with a different panel organized around each of them. The use of the power point is less recommended. However you may use it projecting it on your own laptop. The audience generally fits around the table (10-15 persons), which makes it a great space for in-depth discussion on your research.
- → Distributed papers: Please send your papers to the session organizers and, of possible, bring a few hard copies. Contact the panel chair to see if there is a possibility to briefly mention the core argument of your text (2 minutes max). Your paper may be included in a forthcoming publication based on the panel. Don't miss that opportunity!
- → Integrative sessions: These short panels gather leading scholars at lunchtime.

Open Movements connects the analysis of social movements with broad social changes, considering the study of social movements as providing elements for a better understanding of both specific social actors and society as a whole. We intend to 'open up' social movements and social movements studies in five ways: connecting social movements with broad social changes; opening a dialogue with and learning from the South; combining the local, national, regional and global scales; learning from and with social movements; opening a space for a public sociology of social movements. *Open Movements* is a joint initiative of openDemocracy and the ISA47.
